

Ratings & Reviews – Terms & Conditions

1. General

These terms and conditions apply to the use of the "Ratings & Reviews" feature of the www.okikoo.com / www.okikoo.ch website.

By accessing the site and using this feature, users expressly agree to the terms and conditions contained herein.

Users unwilling or unable to be bound by the present terms should refrain from using the feature.

2. Eligibility

Users wishing to use the "Ratings & Reviews" feature should be at the least 18 years of age

3. User Account

Persons wishing to use the "Ratings and Reviews" feature for the first time are required to open an account. This requires the user to enter a name (or an alias), an email address and a password.

Within a few minutes of opening an account, an email message is sent to the email address of the user; an account is validated by clicking on the link contained in this message.

Subsequent Ratings & Reviews require a simple login (email address and password).

4. Ratings & Reviews – Overview

A rating consists of 1 to 5 stars which broadly speaking may be interpreted as follows:

The average of all ratings for every company and/or professional is shown on the site alongside other information pertaining to the company or professional in question.

A review, which may contain up to 320 characters consists of a statement or comment pertaining to a company or a professional.

Any review may be consulted by any visitor to www.okikoo.com.

5. Restrictions on use

Users hereby agree that they will:

- (i) Use appropriate language
- (ii) Give fair and unbiased opinions
- (iii) Avoid insulting, political or discriminatory comments
- (iiii) Not use the feature for promotional or commercial purposes

6. Abuse and Responsibility

A review which is considered inappropriate or abusive may be reported (by clicking on "report an abuse").

A user may not use the Ratings & Reviews feature for the same company or professional more than once every 3 days.

A user is personally responsible for comments added and assumes all risks associated with adding content which is deemed inappropriate, offensive, inaccurate or misleading.

The management of okikoo.com may at its sole discretion, delete any comment and/or close or invalidate any user account without giving prior notice.
